Any member of the Society who wants to add the name of another member to the above slate may do so by submitting a petition signed by at least ten Society members. This petition must include the name, complete address, and phone number of the nominee, the office for which she or he is being nominated, and a signed statement from the nominee indicating agreement to run. The nominee must also provide a brief biography and a platform statement of no more than 250 words.

Scan, save, and send an electronic copy of all nomination-by-petition materials to Juwen Zhang at juwen@willamette.edu no later than September 25.

We will invite all candidates to participate in a Candidates' Forum on Saturday afternoon, October 16, at the annual meeting in Nashville. Secure online voting will open around November 1 and will continue through December 31. We will announce

election results shortly after the first of next year on the AFS web site. Those elected will take office in January 2011.

George Mason University Seeks New Faculty Member

The Department of English in the College of Humanities and Social Sciences at George Mason University announce a tenure-track assistant professor position in Folklore beginning Fall 2011. Completion of a PhD in Folklore or a related field is required before August 2011. Candidates should have strong scholarly credentials in folklore and should be ready to teach in our growing Folklore Studies Program. The field of specialization is open, but we are particularly interested in candidates whose work is globally focused with a preference in one of the following areas: Folklore and New Media, Folklore of US ethnic groups or global identities in the US, African folklore, Chinese folklore, Russian Folklore, or South Asian folklore. Must demonstrate potential for excellence in folklore scholarship and in graduate and undergraduate teaching, including introductory courses in Folklore and general education courses in composition and literature.

Call for Proposals: Editor, AFS *Public Programs Bulletin/Newsletter* and *AFS Public Folklorist Directory*

The AFS Public Programs Section is seeking applicants for the editorship of the *Public Programs Bulletin/Newsletter* and the *AFS Public Folklorist Directory*.

Qualifications:

Familiarity with public folklore and with the American Folklore Society website Ability to write and to edit short articles for web publication Ability to meet deadlines
Knowledge of web publishing is helpful

Duties:

Maintain *Public Programs Bulletin* online, as part of the American Folklore Society website. It may take the form of a wiki site or of a more stable website (to be determined)

Coordinate webpage with American Folklore Society director, the web editor, and the Public Programs section conveners.

E-mail notices requesting submissions and directory updates

Contact public folklorists, as needed

Edit and proof submitted copy (editing is usually light, but submissions need to be put into a consistent format)

Select photos, resizing and cropping as necessary [requires a photo editing program] Assemble and format the Bulletin

Maintain and update the directory of public folklorists and public programs Send electronic alerts to AFS Public programs section members when Bulletin is posted Submit invoices for reimbursement to AFS and the public programs section conveners

Estimated work time: 100 to 150 hours per year, depending on the frequency of publication

Estimated expenses: Editor's time, use of computer and printers, software, phone, and incidentals (supplies, paper, postage)

Proposals should include:

- 1. A statement of the applicant's vision for the Public Programs Bulletin: What kind of software would you use? How would you organize/format the Bulletin? Describe your role as editor.
- 2. A proposed publication schedule: how often, and when, would the Bulletin be published (once a year? more frequently? ongoing updates?).
- 3. A draft annual budget.
- 4. A resume.
