## Recent Articles, Pamphlets, and Dissertations in Indiana History

Editor's Note. This list of articles, pamphlets, and dissertations published in 1980 and 1981 is intended as a bibliographic contribution to Indiana's history. As our first list of this kind, it is neither complete nor systematic in coverage. With this first effort as an experiment we hope to be able to present a list in each March issue of the Indiana Magazine of History.
